## KEY GOVERNMENTAL UPDATES

## Detailed Damage Assessment (DDA) of multi-hazard affected private households and their recovery and reconstruction process

The National Disaster Risk Reduction and Management Authority (NDRRMA), following the key decision of the 16th meeting of the National Council for Disaster Risk Reduction and Management chaired by Rt. Hon. Prime Minister K.P. Sharma Oli, has launched the Detailed Damage Assessment (DDA) process for households affected by the Jajarkot earthquake. This initiative aligns with the Disaster-Affected Private Housing Retrofitting, Reconstruction, and Recovery Grant Distribution Guideline, aimed at ensuring a systematic and efficient assessment of affected households to determine their eligibility for financial and technical assistance.

On 16th February, a team of technical experts was deployed to Jajarkot and Rukum West to conduct training for local technical staff on the DDA process. The training sessions, facilitated by NDRRMA in technical support from NHSRP, were attended by engineers from local governments, the Ministry of Urban Development (MoUD), the Institute of Engineering (IOE), and technical staff from national and international NGOs. A total of 124 personnel were trained during three separate training events held over three days in the affected regions. These trained personnel have now begun conducting field assessments across the affected areas. The DDA is a crucial step in the earthquake recovery process, allowing for a comprehensive evaluation of damaged private housing based on both socio-economic and technical factors. The damage is categorized into different grades, which will determine whether affected households are eligible for retrofitting, reconstruction, or resettlement support.




 To enhance the effectiveness of the DDA process, NDRRMA has been collaborating with the Institute of Engineering, Center for Disaster Studies (IoE/CDS) and key development organizations including UNRCO, CRS Nepal, CARE Nepal, DCA, IOM, People in Need, CSRC, Save the Children, WFP and UNDP. A total of 98 technical personnel have been deployed from various organizations, that includes IOE (20), UNRCO (12), CRS Nepal (19), Save the Children (5), CARE Nepal (6), CSRC (2), UNDP (8), PIN (2), MoUD (13), DCA (2), Build Up Nepal (2), WFP (2) and IOM (5). However, NDRRMA estimates that 218 technical personnel are required to assess the 76,308 affected households across Jajarkot and affected districts, leaving a gap of 120 personnel that still needs to be filled through additional support. In addition to the Jajarkot initiative, NDRRMA has begun the enrollment process for households affected by the Doti earthquake, which was assessed two years ago. As part of strengthening recovery efforts, NDRRMA is planning to set up sub-offices in Jajarkot, Achham, and Bajhang districts to improve coordination and support on the ground.

NHSRP provides technical assistance in training, data management, MIS system, while also overseeing quality control and coordination with partner organizations to address staffing gaps. This collaborative effort marks a significant step toward rebuilding stronger, more resilient communities in the earthquake-affected regions, ensuring that affected households receive the timely and necessary support to rebuild their homes and livelihoods.

## executive committee approves key decisions for recovery and response

The 29th meeting of the Disaster Risk Reduction and Management Executive Committee was held on February 27, 2025, under the chairmanship of Honorable Ramesh Lekhak, Minister of Home Affairs. Several key decisions were made to accelerate post-disaster recovery and response efforts.

 To facilitate the Detailed Damage Assessment (DDA) of private housing affected by the Western Nepal earthquake and to strengthen recovery and reconstruction efforts, the meeting approved the deployment of additional human resources and the necessary budget for office management. Recognizing the need for a localized approach, the National Disaster Risk Reduction and Management Authority (NDRRMA) proposed establishing three sub-offices in Jajarkot, Bajhang, and Achham districts. These offices will oversee and support private housing recovery and reconstruction efforts to the affected local governments following the recent earthquakes in Doti, Bajhang, and Jajarkot. Based on the executive committee's decision, the Cabinet has approved the establishment of these sub-offices, paving the way for implementation, which is expected to enhance the efficiency of the recovery process.

Additionally, the meeting approved the Disaster Volunteer Mobilization Training Curriculum, 2018, which aims to strengthen disaster response capacity through trained volunteers. The payment of air rescue expenses for disaster-affected individuals from the Disaster Management Fund was also approved, ensuring timely financial support for emergency evacuations.

These decisions mark significant progress in Nepal's disaster response and recovery efforts, aiming to provide timely support to affected communities and improve disaster preparedness at the local level.

## Japan Provides Grant Assistance to Support Earthquake Recovery in Jajarkot and Rukum West

The grant will play a crucial role in addressing urgent needs while laying the foundation for disaster-resilient communities.



This collaboration underscores Japan's continued support for Nepal's disaster recovery efforts, reinforcing the shared vision of building stronger and safer communities.

## National Bamboo Conference 2025 Pre-Event Sets the Stage for Sustainable Housing Innovations

On 11 February 2025, the National Bamboo Conference 2025 Pre-Event set the stage for groundbreaking discussions on bamboo's role in sustainable housing and construction. Bringing together experts, policymakers, and industry leaders, the event focused on three key themes: scaling challenges and private sector engagement, engineering and disaster resilience, and policy advocacy with multi-stakeholder collaboration. Participants explored strategies to integrate bamboo into mainstream construction, enhance its structural durability, and develop supportive policies for wider adoption. Since 2017, Habitat for Humanity Nepal, in collaboration with local governments and partners, has championed the use of sustainable, locally preferred materials in housing, particularly for marginalized communities. However, scaling these efforts remains a challenge—how can engineering practices be refined, and how can bamboo structures be made more disaster-resilient? The conversation is far from over. The National Bamboo Conference 2025, scheduled from 27 February to 1 March in Diktel, Khotang district, will further drive innovation, policy reforms, and strengthen partnerships in bamboo-based construction. ## Safer Internet Day 2025: A Collective Effort for Cyber Safety

On February 11, 2025, Nepal marked Safer Internet Day 2025, emphasizing cyber safety and online protection for children and youth. Organized by the Nepal Telecommunications Authority, National Child Rights Council, Ministry of Women, Children and Senior Citizen – Nepal, and Ministry of Communication and Information Technology, the event was held in collaboration with Joining Forces, Net4Good Alliance, and Creation Society





The day featured two key sessions: "Keeping Children Safe on the Internet: A Webinar on Child Online Protection" and "National Workshop on the Role of Government and Service Providers for a Safer Internet." Both sessions were a resounding success, with engaging discussions led by experts, an interactive Q&A segment, and valuable insights into strengthening child online safety and cybersecurity measures.

As digital threats evolve, Nepal's commitment to cyber safety continues to grow. The discussions from Safer Internet Day 2025 are expected to shape future policies and collaborative efforts to create a safer online environment for children and vulnerable communities.

## Regional Workshop on Scaling Up Locally Led Adaptation in South Asia

From February 12–14, 2025, the Global Center on Adaptation (GCA) and DanChurchAid (DCA) organized a regional practitioner workshop on Locally Led Adaptation (LLA) in Kathmandu, Nepal. Hosted by the Ministry of Forests and Environment, Nepal, the event focused on regional climate vulnerabilities and LLA initiatives in key sectors, including food security, water resource management, urban development, infrastructure, and climate finance. The workshop convened LLA practitioners, government officials, and private sector representatives to discuss best practices and challenges in scaling up locally led adaptation efforts.



Key takeaways from the workshop highlighted the importance of preventing fragmentation and duplication by integrating LLA within existing government structures and community practices. Effective use of climate finance requires transparent monitoring mechanisms to ensure donor and recipient accountability while minimizing reporting burdens for local communities. LLA initiatives should align with government policies supporting farmers and food security to maximize impact. Scaling LLA involves not just expanding community-led practices but also contextualizing and strengthening them through policy support, resources, and infrastructure. Climate adaptation strategies must be tailored to urban, peri-urban, and rural areas to address specific vulnerabilities. Additionally, effective communication of scientific knowledge to local communities is crucial in avoiding maladaptation and ensuring informed climate action. This workshop emphasized the need for coordinated, policy-aligned, and well-funded LLA strategies that prioritize community needs while strengthening resilience across South Asia.

## NHSRP PROVINCIAL ENGAGEMENTS

### PROVINCIAL UPDATES - KARNALI

#### Provincial Disaster Management Executive Committee (PDMEC) meeting

The Provincial Disaster Management Executive Committee (PDMEC) meeting was **convened on February 5, 2025**, at the MoIAL Hall, under the chairmanship of Honorable Chief Minister Mr. Yam Lal Kandel. The Meeting was facilitated by the Secretary of MoIAL and attended by Secretaries from various ministries, representatives from all security forces, selected development sector stakeholders, and members of the press. Key agenda items included: Approval of bills and expenses related to helicopter services deployed for disaster response, Review of fund distribution under the District Disaster Management Fund, specifically allocated for Rescue and Relief Distribution for Disaster Victims, Procurement of disaster search, rescue, and relief materials and Status report on monsoon- and fire-affected housing reconstruction and resettlement efforts.

During the meeting, **NHSRP presented a comprehensive status report on monsoon- and fire-affected houses**. According to the report, a minimum of NPR 10 crore will be required to support recovery efforts, with

disaster-affected households.

## Provincial-Level Interaction on Housing Insurance Successfully Held in Karnali

On February 10, 2025, the Ministry of Internal Affairs and Law (MoIAL), Karnali Province, in collaboration with the Pratibaddha project, successfully organized a one-day interaction program in Birendranagar, Surkhet. The event focused on the Housing Insurance Procedures 2081, which the ministry is preparing to implement. Key presentations were delivered by: Mr. Pushparaj Shahi, Secretary of MoIAL, on national and provincial disaster policies and the rationale for housing insurance, Mr. Neel Prasad Lamichhane, Provincial Head of the National Insurance Authority (NIA), on the role of insurance in risk transfer and Nepal's existing insurance framework and Mr. Uttam Gautam, Under Secretary at MoIAL, on the key provisions of the Housing Insurance Procedures 2081.



The session facilitated valuable recommendations from participants, including representatives from provincial ministries, eleven municipalities across **Jajarkot, Dailekh, Surkhet, Salyan, and Kalikot**, insurance companies, municipal associations, journalists, and development partners. This initiative represents a significant step toward enhancing disaster resilience and financial protection in Karnali Province through comprehensive housing insurance policies.

## Support for Provincial Emergency Operations Center (PEOC) in Daily Bulletin Publication

The National Housing and Settlements Resilience Platform (NHSRP) / People in Need (PIN) continues to provide technical support to the Provincial Emergency Operations Center (PEOC) in publishing the daily provincial bulletin, ensuring timely dissemination of disaster-related information.

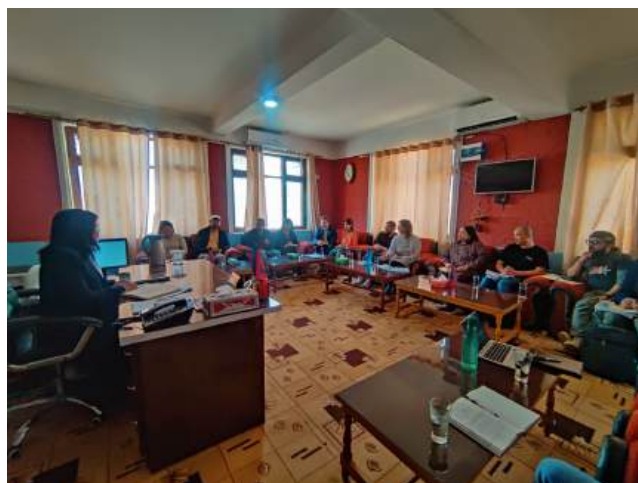


Agriculture, and Livestock (MoIAL) for Lumbini Province, demonstrating the government's commitment to advancing risk management and strategic rural support programs.

### **Training of Trainers (ToT) on Climate Information Application for DRRM Sector, 11-12 February, 2025, Hetauda Bagmati Province**

The Training of Trainers (ToT) on "Climate Information Application for the DRRM Sector" was organized by NDRRMA and the Regional Integrated Multi-Hazard Early Warning System (RIMES). The participants included Disaster Focal Persons and Computer Operators from 13 districts of Bagmati Province. The SATARK DSS monitors flash floods, forest fires, landslides, and lightning risks by integrating data from the Department of Hydrology and Meteorology (DHM) and regional/global climate centers. It supports evidence-based decision-making for disaster preparedness, response, and long-term risk reduction.



## **PROVINCIAL UPDATES - MADESH**

### **Strengthening Climate Resilience: Capacity Building on Climate Change Adaptation and Advocacy**





From February 19 to 21, 2025, Plan International Nepal, in partnership with Prakriti Resources Center, conducted a three-day Climate Change Adaptation and Advocacy training in Janakpur, Dhanusha. The training aimed to strengthen the capacity of partner organizations in climate resilience, adaptation, and advocacy. Seventeen participants engaged in in-depth discussions on climate justice, gender-inclusive approaches, and policy frameworks such as the Paris Agreement and Nepal's National Climate Change Policy. A key focus was on the differentiated impacts of climate change on vulnerable communities, emphasizing the need for intersectional climate action. The second and third days of the training delved into practical climate adaptation strategies, risk assessment, and advocacy tools. Participants developed action plans to address climate risks and explored ways to integrate climate adaptation into their organizational goals. Through interactive group activities, they analyzed climate policies at international, national, and local levels, fostering knowledge exchange on climate governance.

Also oriented on newly endorsed Procedure for Disaster-Affected Private Housing Strengthening, Reconstruction, and Resettlement 2081. Following the orientation, the technical team initiated data entry into the BIPAD portal.

wildfire. During a program held in Udayapur, the NDRRMA's Under-Secretary and Spokesperson, Dr. Dijan Bhattarai, handed over the pump and other fire control equipment to Chief District Officer Hari Prasad Ghimire.



Diktel Bazar, the commercial hub of Khotang district, successfully hosted Nepal's first-ever National Bamboo Conference from February 27-29, 2025. Organized by Diktel Rupakot Majhuwagadhi Municipality, the event aimed to promote bamboo-based industries, employment generation, and indigenous knowledge. The conference coincided with Shivaratri, attracting Hindu and Buddhist devotees to nearby Halesi.



The three-day event gathered academicians, researchers, entrepreneurs, and policymakers. Mayor Tirtha Prasad Bhattarai highlighted discussions on bamboo-based industries, research presentations, and an exhibition featuring bamboo products like a bamboo-based balm for wrinkle reduction. The city-wide inaugural procession added a cultural touch.

A key highlight was the presentation of 35 research papers. While Prof. Dr. Annapurna Das delivered an engaging talk, bachelor's student Deepa Tamang captivated the audience with her research on bamboo leaves as food for red pandas in Langtang National Park. Another paper explored bamboo's potential for retrofitting stone masonry buildings and constructing reinforced permanent shelters using red laterite soil, which provides compressive strength comparable to brick cement mortar. The study also addressed bamboo's termite vulnerability and outlined indigenous and modern preservation techniques. The conference concluded with a 35-point declaration, including:

- Establishing Diktel as Nepal's bamboo capital
- Setting up a Bamboo Research and Education Centre
- Holding the conference every three years

The event's success was credited to Mayor Bhattarai's leadership and Minister Shah's unwavering support. While many criticize federal and provincial governments, this conference proved the power of local governance. By advancing bamboo-based industries, Diktel has taken a significant step toward economic growth and sustainable development.





## September Flood and landslide response at Phidim Rural Municipality, Panchthar : 25449

Caritas Nepal has extended a helping hand to the resilient communities of Phidim Rural Municipality, Panchthar District, following the devastating flood and landslide in September 2024.

In an effort to support families who lost their homes completely, we've distributed CGI sheets and kitchen utensils to 125 affected families. This assistance aims to help them rebuild their homes and lives. Together, we stand strong. Also 250 students received essential educational materials, ensuring they can continue their studies without interruption, despite the challenges. ## Joint Monitoring Visit at Bairedada Integrated resettlement ,Khadabari Mun ,Sankhuwasava and Chitre integrated Resettlement site,silichung RM, Sankhuwasava

### Bairedada Integrated resettlement, Khadabari Mun, Sankhuwasava



The joint monitoring visit was conducted on February 23, 2025, at Bairedada Integrated Resettlement in Khadabari Municipality, Sankhuwasabha, to assess the progress and quality of construction, explore ways to expedite project completion, and facilitate the release of government tranches. This initiative follows the catastrophic landslide that struck Besinda and Chepchewa villages in Silichong Rural Municipality, Sankhuwasabha District, three years ago. The disaster claimed nine lives, displaced 92 households, and devastated homes and critical infrastructure, leaving the affected communities in urgent need of assistance. A coordinated response from local, provincial, and national governments, in collaboration with development partners such as the Nepal Housing Reconstruction Support Project (NHSRP), laid the groundwork for recovery efforts. Out of the 92 displaced households, 55 have been resettled in Bairedada Integrated Resettlement, while the remaining 37 have been relocated to the Chitra Integrated Settlement in Silichong Rural Municipality.



### Chitre Integrated resettlement, Silichung Rural Municipality, Sankhuwasava

The resettlement work has finally commenced at Chitre, Silichong Rural Municipality-1. Out of the 92 households displaced by the landslide on 2077/03/27, 37 families have been relocated to this settlement. Currently, private housing construction is underway at the site. The ongoing reconstruction efforts aim to provide permanent, safer homes for the affected families, ensuring their long-term stability and resilience.

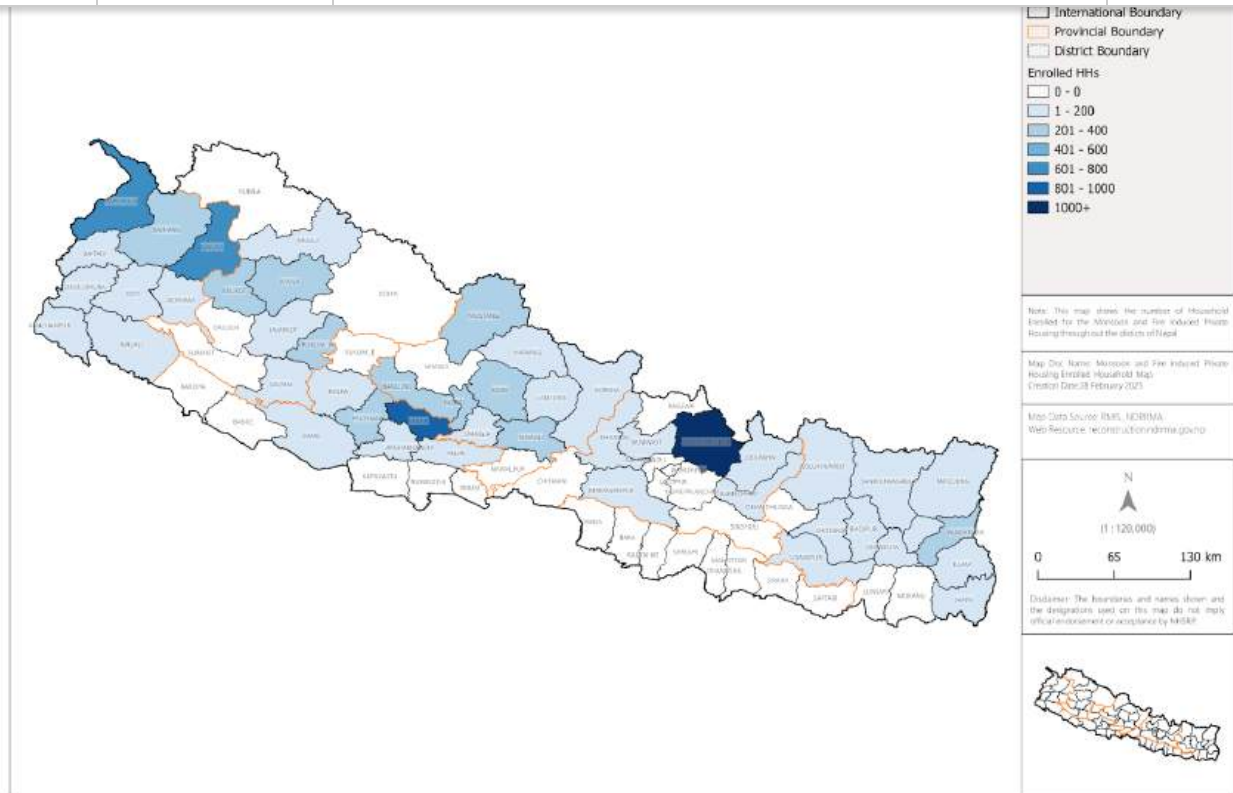

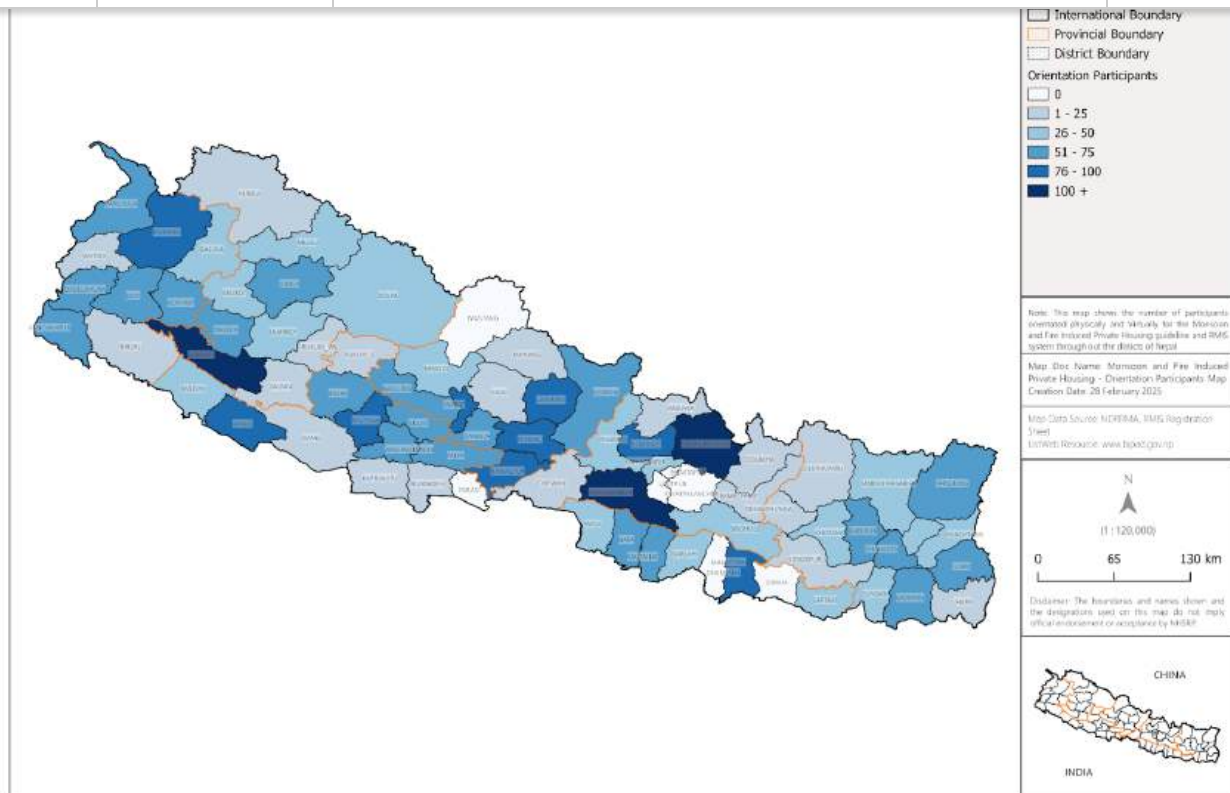


## Enrolled households progress for Monsoon and Fire Induced Private Housing Reconstruction (28 February 2025)



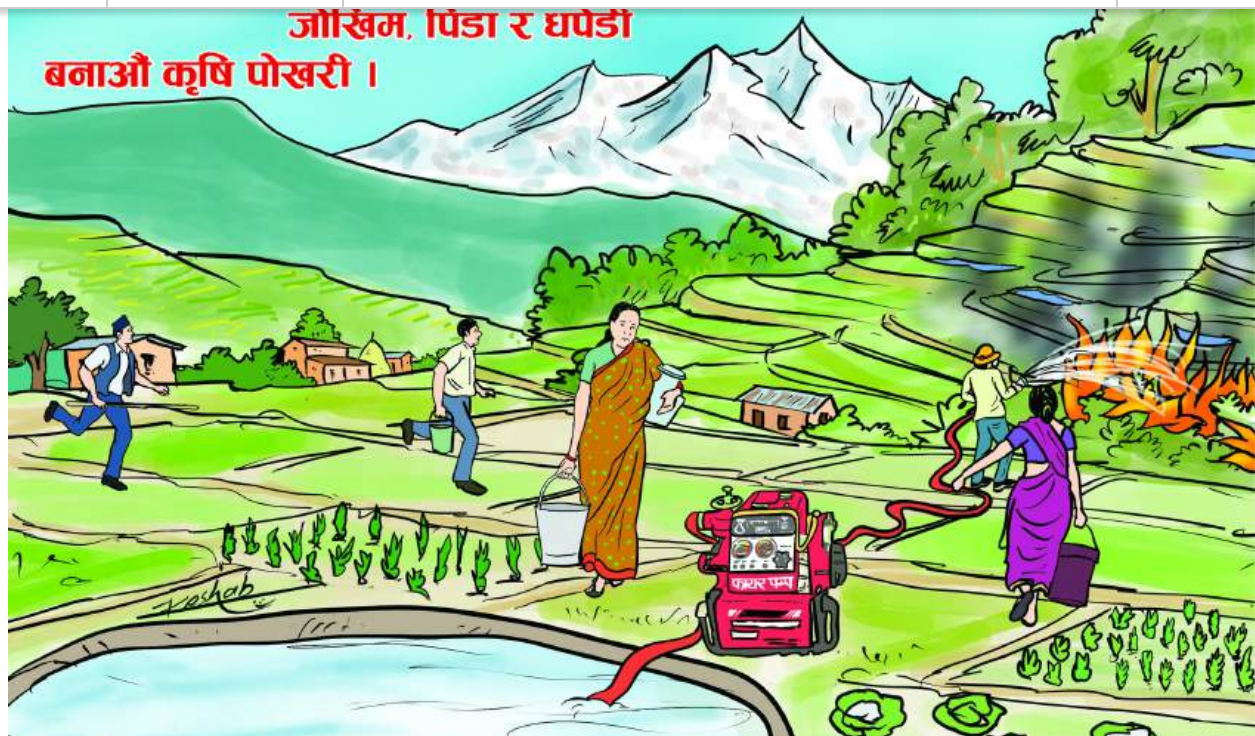
